Adoption of Minutes:

A motion was made by Councilman Mitchell, seconded by Councilman Roth with Councilwoman Napolitani abstaining and all others voting "yes" to adopt the September 23, 2023 regular and executive meeting minutes of the Belvidere Town Council.

Public Comment:

There was no public comment at this time.

Matters to be Addressed:

Council received the resignations of Kurt Nillson from the Pool Committee effective immediately and Ralph Price as Construction Official effective December 31, 2023. **A motion** was made by Councilman Mitchell, seconded by Councilman Roth and carried to move forward with the search for a replacement(s) for Ralph Price.

A motion was made by Councilman Roth, seconded by Councilwoman Napolitani and carried approving the Victorian Day event application for 2024 with all recommendations from the Chief of Police and the DPW Deputy Director.

Resolutions:

A motion was made by Councilman Roth, seconded by Councilman Mitchell and carried to adopt Resolution No. R2023x73. RESOLUTION NO. R2023x73 TOWN OF BELVIDERE WARREN COUNTY, NEW JERSEY A RESOLUTION TO AMEND AND UPDATE THE PERSONNEL POLICIES AND PROCEDURES MANUAL AND EMPLOYEE HANDBOOK

WHEREAS, the Municipal Excess Liability Joint Insurance Fund ("MEL") has made suggested modifications to the Personnel Policies and Procedures Manual and Employee Handbook ("PPPM") to reflect current changes in law;

NOW, THEREFORE, BE IT RESOLVED by the Belvidere Town Council that the following modifications will be made to the PPPM:

• <u>Americans with Disability Act</u>

Pregnancy, pregnancy-related medical condition, breast feeding or childbirth was added to reflect changes in the law.

<u>Sick Leave Policy</u>

In accordance with COVID-18-related updates to the Earned Sick Leave Law, an additional reason for which sick leave may be used was added in both the PPPM and the Employee Handbook. In addition, a note was added in both the PPPM and Employee Handbook to clarify that employees may choose to require up to seven (7) days' notice for foreseeable sick leave usage under the Earned Sick Leave Law.

• <u>Alcohol and Drug-Free Workplace</u>

Language that is no longer applicable due to the legalization of cannabis was removed throughout the policy. The language "for certain employment positions" was added after "Cannabinoids" because employers will no longer need to test for cannabis in pre-employment panels for most positions. In the Employee Handbook, the word "unlawful" was removed before "drugs" in order to make clear that the use of cannabis in the workplace is still prohibited.

Domestic Violence Policy

Letter (E) under the Domestic Violence Reporting Procedures in the PPPM was removed due to it only being applicable to issues between State employees.

• <u>New Jersey Family Leave</u>

An additional reason that leave may be taken was added in both the PPPM and Employee Handbook in accordance with COVID-19 related updates to the law. Changes were also made in the PPPM Policy to reinforce and clarify that NJFLA leave may be taken consecutively, intermittently or on a reduced schedue with little restriction and to clarify the notice requirements for intermittent leave.

• <u>Overtime</u>

The highly-compensated employee overtime exemption was updated from \$100,000 to \$107,432 to reflect current law.

Personnel Records

Language was added to reflect changes in the law regarding the protection and access of personnel records.

Chapter 103 Swimming Pool Advisory Committee

§ 103-2. Members; terms; appointment.

The Committee shall consist of five members with a minimum of three members of the general populace who shall be residents of the Town of Belvidere. The Committee members shall be appointed for a term of two years. There shall be allowed up to two alternate members appointed at large, one of whom must be a resident of the Town of Belvidere. All members shall be appointed or removed by the Mayor with the advice and consent of the Council.

BOND ORDINANCE PROVIDING AN APPROPRIATION OF \$135,000 FOR ACQUISITION OF A DUMP TRUCK FOR THE DEPARTMENT OF PUBLIC WORKS IN AND BY THE TOWN OF BELVIDERE, WARREN COUNTY, NEW JERSEY AND AUTHORIZING ISSUANCE OF \$85,000 IN BONDS OR NOTES OF THE TOWN OF BELVIDERE FOR FINANCING PART OF THE APPROPRIATION

BE IT ORDAINED by the Belvidere Town Council (not less than two-thirds of all members affirmatively concurring) as follows:

SECTION 1:

The improvements described in Section 3 of this bond ordinance (the "Improvements") are hereby authorized to be undertaken by the Town of Belvidere (the "Town") as capital improvement. For the said Improvement there is hereby appropriated the amount of \$135,000, such sum includes the sum of \$50,000 as a down payment (the "Down Payment") required by the Local Bond Law of the State of New Jersey, constituting Chapter 2 of Title 40A of the New Jersey Statutes, as amended and supplemented (the "Local Bond Law"). The Down Payment is now available by virtue of provision in one or more previously adopted budgets for down payment for capital improvement purposes.

SECTION 2:

In order to finance the additional cost of the Improvement not covered by application of the Down Payment, negotiable bonds of the Town are hereby authorized to be issued in the principal amount of \$85,000 pursuant to the provisions of the Local Bond Law (the "Bonds"). In anticipation of the issuance of the Bonds and to temporarily finance said improvements or purposes, negotiable bond anticipation notes of the Town are hereby authorized to be issued in the principal amount not exceeding \$85,000 pursuant to the provisions of the Local Bond Law (the "Bond Law (the Bond Law (

SECTION 3:

(a) The improvements hereby authorized and the purpose for the financing of which said obligations are to be used is for the acquisition of a dump truck for the Department of Public Works.

(b) The estimated maximum amount of Bonds or Notes to be issued for the purpose of financing a portion of the cost of the Improvement is \$85,000.

(c) The estimated cost of the Improvement is \$135,000 which amount represents the initial appropriation by the Town.

SECTION 4:

All Bond Anticipation Notes issued hereunder shall mature at such time as may be determined by the chief financial officer of the Town (the "CFO"); provided that no Notes shall mature later than one year from its date. The Notes shall bear interest at such rate or rates and be in such form as may be determined by the CFO. The CFO shall determine all matters in connection with Notes issued pursuant to this ordinance, and the signature of the CFO upon the Notes shall be conclusive evidence as to all such determinations. All Notes issued hereunder may be renewed from time to time subject to the provisions of Section 8(a) of the Local Bond Law. The CFO is hereby authorized to sell part or all of the Notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The CFO is directed to report in writing to the Town Council of the Town at the meeting next succeeding the date when and any sale or delivery of the notes pursuant to this ordinance is made. Such report must include the amount, the description, the interest rate an the maturity schedule of the Notes sold, the price obtained and name of the purchaser.

SECTION 5:

The capital budget of the Town is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full details of the amended capital budget and capital program as approved by the Director of the division of Local Government Services, Department of Community affairs, State of New Jersey is on file with the Municipal Clerk and is available for public inspection.

SECTION 6:

The following additional matters are hereby determined, declared, recited and stated:

(a) The Improvements described in Section 3 of this bond ordinance are nor current expenses and are capital improvements or properties that the Town may lawfully make or acquire as general improvements and no part of the cost thereof has been or shall be specially assessed on property specifically benefitted thereby.

(b) The period of usefulness of the Improvements within the limitations of the Local Bond Law, and according to the reasonable life thereof computed from the date of the Bonds authorized by this Bond Ordinance, is five (5) years.

(c) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Municipal Clerk and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services, Department of Community affairs, State of New Jersey. Such statement shows that the gross debt of the Town, as defined in the Local Bond Law, is increased by the authorization of the Bonds and Notes provided in this bond ordinance by \$85,000 and the obligations authorized herein will be within all debt limitations prescribed by the Local Bond Law.

(d) An aggregate amount not exceeding \$5,000 for items of expense listed in and permitted under Section 20 of the Local Bond Law is included in the estimated cost of the Improvements, as indicated herein.

SECTION 7:

Any funds received from time to time by the Town as contributions in aid of financing the purposes described in Section 3 of the ordinance shall used for financing said Improvements by application thereof either to direct payment of the cost of said Improvements or to the payment or reduction of the authorization of the obligations of the Town authorized therefor by this bond ordinance. Any such funds received may, and all such funds so received which are not required for direct payment of the cost of said Improvements shall, be held and applied by the Town as funds applicable only to the payment of obligations of the Town authorized by this bond ordinance.

SECTION 8:

The full faith and credit of the Town are hereby pledged to the punctual payment of the principal of and interest on the obligation authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the Town, and the Town shall be obligated to levy ad valorem taxes upon all the taxable property within the Town for the payment of the obligations and the interest thereon limitations of rate or amount.

SECTION 9:

The Chief Financial Officer of the Town is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of obligations of the Town and to execute such disclosure document on behalf of the Town. The Chief Financial Officer is further authorized to enter into the appropriate undertaking to provide

secondary market disclosure on behalf of the Town pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the "Rule") for the benefit of holders and beneficial owners of obligations of the Town and to amend such undertaking from time to time in connection with any change in law, or interpretation thereof, provided such undertaking is and continues to be, in the opinion of a nationally recognized bond counsel, consistent with the requirements of the Rule. In the event that the Town fails to comply with its undertaking, the Town shall not be liable for any monetary damages, and the remedy shall be limited to specific performance of the undertaking.

SECTION 10:

This bond ordinance constitutes a declaration of official intent under Treasury Regulations section 1.150-2. The Town reasonably expects to pay expenditures with respect to the Improvements prior to the date that the Town incurs debt obligations under this Bond Ordinance. The Town reasonably expects to reimburse such expenditures with the proceeds of debt to the incurred by the Town under this bond ordinance. The maximum principal amount of debt expected to be issued for payment of the costs of the Improvement is \$85,000.

SECTION 11:

This bond ordinance shall take effect 20 days after the first publication after final adoption, as provided by the Local Bond Law.
