WHEREAS, said renewal membership terminates as of January 1, 2023 at 12:01 a.m. eastern standard time, unless earlier renewed by agreement between the Public Entity and the Fund; and

WHEREAS, the Public Entity is afforded the following types of coverages:

WHEREAS, the Public Entity desires to renew said membership.

Public Comment:

Rheva Smickel - thank you to Laurel Napolitani for her years of service to the community and proud to say "that's my Councilwoman".

Nancy Mason - redevelopment agreement with BUR and PILOT program? Kevin Benbrook - everything that was in the original redevelopment agreement remained but the new agreement was expanded to include a commercial option. The developer must comply with all current standards.

Mary Perkins - Resolution No. R2022x64 regarding cannabis cultivation.

Rheva Smickle - Scout Home progress? Construction has begun and we are shooting for the first quarter of the New Year for completion.

Lauren Atkins - if approved by Planning Board, will the warehouse come back to Council for approval? Kevin Benbrook - no, Council will work with the Redevelopment Plan and negotiate

the PILOT.

Laura Kennedy - PILOT. Kevin Benbrook - in addition to PILOT Town will receive community impact fees, affordable housing fees and roll back taxes. The PILOT is a useful tool for the Town allowing flexibility with additional revenue.

Mary Perkins - tax abatements of warehouse? No tax abatements.

Nancy Mason - Town liability as the redevelopment entity? Kevin Benbrook - no protection in the agreement but developer must adhere to the Tier A Stormwater Management standards. Rheva Smickle - everything has a silver lining

Linda Stettler - redevelopment plan/PILOT not in favor because school and County get cut out of the tax payments. Additional trucks on Market Street. Barrier should be installed at the warehouse exit to keep trucks from turning left.
